UTA Edenred laiendab oma võrku Soomes Teboil partnerluse kaudu

- **Lepinguga lisandub UTA Edenredi Soome võrgustikku 430 Teboili tanklat, mis teeb kokku umbes 1000 tanklat üle kogu riigi.**
- **Teboili tanklates pakutakse diislikütust, bensiini, HVO-d ja AdBlue'd ning 24/7 iseteenindusvõimalust.**
- **Esialgu on UTA klientidele saadaval umbes 200 raskeveokitele mõeldud tanklat. Lähikuudel lisandub Teboili tanklaid juurde.**

Kleinostheim, Saksamaa – Euroopa juhtiv liikuvusteenuste pakkuja [UTA Edenred](#) ja Edenredi ettevõte laiendasid oma võrku Soomes partnerluse kaudu Vantaas asuva energiatevõtjaga Oy Teboil Ab (Teboil). Lepingu raames lisandub UTA võrgustikku Soomes umbes 430 Teboili kaubamärgiga tanklat. Esimeses etapis saavad UTA klientid kasutada umbes 200 tanklat, mis on mõeldud ka raskeveokitele. Lähikuudel lisandub veel 230 tanklat, sealhulgas sõiduautotanklad.

Partnerlus Teboiliga suurendab UTA Edenredi võrku Soomes kokku umbes 1000 tanklani üle kogu riigi.

Teboili tanklatel on erinevad kontseptsioonid eri sihtrühmade jaoks. Näiteks Teboil D tanklad on mõeldud raskeveokitele, samas kui Teboili kiir- ja automaattanklad on mõeldud sõiduautodele. Kõigis tanklates pakutakse diislikütust, sh talvist diislikütust, bensiini, HVO-d, AdBlue'd ja 24/7 iseteenindusvõimalust UTA klientidele.

Teboili 19 tanklas kehtib UTA klientidele ühtne tariif. Tariifi saab eelnevalt kontrollida UTA Service Centeris.

UTA Edenredi EMEA kaubandusdirektor Lukas Schneider ütleb: „Üle 68 000 kütusetanklaga 37 riigis pakume oma klientidele ulatuslikku võrku kogu Euroopas. Teboili partnerlus on oluline samm meie Skandinaavia võrgustiku arendamisel, mis pakub klientidele veel rohkem võimalusi nende marsruutidel Põhja-Euroopas.“

Oy Teboil Ab turundus- ja kommunikatsionijuht Toni Flyckt ütleb: „Oleme töeliselt põnevil koostööst UTA Edenrediga. Selle partnerluse kaudu saavad UTA Cardi omanikud juurdepääsu umbes 430 uuele tanklale Soomes, sh enam kui 200 D-automaattanklale, mis on mõeldud professionaalsetele sõidukitele. Tarbijatele mõeldud tanklad lisatakse võrku kevadel. Lisaks tanklale saavad UTA Cardi omanikud kasutada ka umbes 80 teenindusjaama, mis on suurepärased kohad lühiajaliseks pausiks reisi ajal.“

Lisaks Teboilile kuuluvad UTA võrku Soomes ka Neste tanklad.
